VI. New Business

a. Hotel Fees – *Petrello/Cantrell MSP*

ADD k. If a school fails to provide their required competition room(s) because they do not register at the hotel, they will be fined \$250 per room. The \$250 will be offered to any school willing to provide an extra room. The Tournament Director will offer the fee to the schools with the greatest number of rooms first (max one room), and then in descending order until enough rooms are found.

l. If a school is unable to get a reservation at the tournament hotel, through no fault of their own (incl. reservation deadline) there will be no penalty assessed.

b. Special Awards – *Koeppel/Petrello MSP*

Create a New Award (Unnamed) for top speaker based on total points. Tabor/Collins will be for total points accumulated in non-interp events. Keeling/Fricke will be for total points accumulated in interp events.

c. Limited Entry Sweeps – *Rao/Ames MSP*

Limited Entry Division is defined as all schools with 18 or fewer slots (slots entered over the 18 slot limit may be declared non sweepstakes at registration with a cap of four non-sweepstakes slots).

d. L/D Slots – *Petrello/Ames MSP*

Change L/D slot limit to "no more than six (6) slots total (incl. Policy, and NFA)."

e. Parli LD – *Petrello/Reinhart MSP*

Eliminate Parli L/D

f. No Shows in IE's *Koeppel/Petrello MSP*

A No-Show will result in removal from the tournament in that event.

g. Limited Entry Sweepstakes Awards *Petrello/Koeppel MSP*

Increase number of plaques for Limited Entry Sweepstakes to six.
