- VI. **New Business**
  - a. **Parli LD** – *Nelson/Elizondo MSP*  
**Add back in Parli LD in the same structure as before (7,9,5,6,3). Limited to four Parli LD slots and retain six slot cap on LD overall. Sweeps weighted 1.5**
  - b. **Student Eligibility** – *Koeppel/Whalen MSP*  
**Increase student eligibility from two to three years.**
  - c. **Judge Eligibility** – *Fleming/McCall MSP*  
**A judge who competed three years at the state tournament must be two years removed from CCCFA competition before being eligible to judge and a judge who competed for two years at the state tournament must be one year removed from CCCFA competition before being eligible to judge.**
  - d. **Tournament Length** – *Opsata/Ames MSP*  
**Host bids will include a proposed schedule including start time and end time. The schedule may be adjusted within the start and end times at the tournament director's discretion.**
  - e. **Tournament Patterns** – *Opsata/Ames MSP*  
**Double Entry will be allowed in Pattern B as well as the C and D Patterns without any restrictions other than the twelve slot limit per pattern.**

- f. **Competition Room Fee Increase** – *Glimes/Koeppel MSF*  
Increase penalty to match cost of hotel rooms at the tournament.
- g. **Parli Prep** *Fleming/Guy MSF*  
Restrict prep material to **Dictionary and Almanac.**
- h. **Debate Speaker Points** *Cantrell/Petrello MSP*  
Prohibit ties on speaker points in debate.
- i. **Extemp Prep** *Fleming/Petrello MSP*  
Students may leave prep room after drawing their topic.
- j. **Three Person Teams in Debate** *Glimes/Petrello MSP*  
No three person teams will be allowed
